ACT Arts Policy Framework Review Reference Group

Role

The ACT Arts Policy Framework Review Reference Group has been established to provide input and support to artsACT on the Review of the ACT Arts Policy Framework including sector analysis and community consultation.

Terms of Reference

- Provide input to artsACT on the ACT Arts Policy Framework, the review of the Framework and sector analysis;
- Participate in, support and provide input to the community consultation components of the Review;
- Provide comment on draft documentation related to the Review of the ACT Arts Policy
 Framework

Membership

The Reference Group will consist of up to six independent members appointed by the Minister for the Arts as recommended by artsACT.

Terms of Appointments

Appointments will be for the period of the Review of the ACT Arts Policy Framework which is expected to be finalised by mid 2015.

Role of the Chair

The role of the Chair, who will be selected from within the membership by the Minister for the Arts, is to facilitate orderly and constructive discussion between members on matters within the Reference Group's Terms of Reference and ensure that any action required is appropriately assigned. The Chair will also liaise with the Secretariat to develop meeting agendas and ensure the progression of actions arising from meetings.

Secretariat Support

Secretariat support to the Reference Group will be provided by artsACT within Chief Minister, Treasury and Economic Development Directorate. The Secretariat will compile agendas, take minutes of meetings and liaise between the Reference Group and other Government agencies as required.

Meeting Schedule

The meeting schedule will be developed in consultation with members of the Reference Group.

Remuneration

Members of the Reference Group will be offered a stipend of \$250 for their involvement in the Reference Group to cover the expenses related to participation.

Conflict of Interest
